Dear Deloaks Neighbors,

It's been some time since our last formal news update so the Board felt it timely to share important news concerning Deloaks. Firstly, we have a new Board which was installed in June 2015. New Board members are **Alvin Landry** (President), **Alvin Dupre** (Vice President) **and Mark Howard** (Member) while returning Board members are **Margaret Zelenka** (Secretary) and **Chad Ermel** (Member). The Board would like to recognize and thank the previous Board members for their outstanding service to Deloaks; **Calvin Campeaux** (outgoing President), **Earl Dugas** and **Judy Ordoyne**.

The Board would like to raise awareness and remind you on certain key issues that affect all Deloaks residents. Firstly, our current budget is in good shape with year-to-date expenditures on track with the budget. We have a cash balance of approximately \$7,600 in checking and \$5,100 in money market accounts. We expect no major capital outlays for the remainder of 2015.

Of serious concern to the Board is the status of delinquent Homeowners fees. As of September 12, 2015, there was a total of approximately \$12,300 owed the HOA in delinquent Homeowner's fees; seventeen (17) Homeowners account for \$11,800 of these accounts receivables. The Board will formally notify these 17 Homeowners of their delinquent status with a request for payment within 30 days. For those Homeowners who fail to settle their outstanding balances, the Board will implement measures as identified in the *HOA Deed Restrictions* until their account is settled in full. It is unfortunate that the Board has to take this action but we cannot continue to operate in this mode.

Finally, the Board continues to receive complaints about unleashed and "wandering" dogs in the neighborhood. It is the responsibility of all homeowners to keep all pets contained within their property or on a leash at all times per St. Tammany Parish Code of Ordinances, *Section 4-126.00 Animals at large; Leash law*. If you see any unleashed pets roaming the neighborhood, <u>please notify the pet owner first</u> (if

known). Otherwise, contact St. Tammany Parish Animal Services at (985) 809-0183 or http://www.stpgov.org/departments/animals. The goal is to keep both the residents and pets in our neighborhood safe.

On the good news front, the common areas and boat launch are looking really good and should not require any significant maintenance for the near term. The new gate at the boat launch is a vast improvement and looks great; it should last a lifetime. **Should you need a new key for the boat launch gate, please contact one of the Board members listed below**.
